1. I, the undersigned, wish to play at The Foundry Athletic Training Centre; I recognize and understand that playing at The Foundry Athletic Training Centre; Those risk include, but are not limited to, the risk of injury resulting from possible malfunction of the equipment used in the Nerf Event and injuries from tripping or falling over obstacles in the game playing field. In addition, I recognize that the exertion of playing in the Nerf Event could result in injury or death.

2. Despite these and other risks, and fully understanding such risks, I wish to play at The Foundry Athletic Training Centre and hereby assume the risks of playing in the Nerf Event. I also hereby hold harmless the " Sponsors" and indemnify them against any or all claims, actions, suits, procedures, costs, expenses (including attorney's fee and expenses), damages and liabilities arising out of, connected with, or resulting from my playing at The Foundry Athletic Training Centre including without limitation, those resulting from the manufacture, selection, delivery, possession, use or operation of such equipment. I hereby release the Sponsors from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify to the Sponsors that I m in good health and do not suffer from a heart condition or other ailment which could be exacerbated by the exertion involved in Nerf Event at The Foundry Athletic Training Centre, I further certify that I am 18 years of age and older.

RELEASE OF LIABILITY, WAVIER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of participating at The Foundry Athletic Training Centre, I hereby agree as follow:

- 1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against The Foundry Athletic Training Centre, their directors, officers, employees, agents and representative (all of whom are hereinafter collectively referred to as "the Releasees")
- 2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of my participation in Nerf Event due to any cause whatsoever, INCLUDING NEGLIGENCE ON THE PART OF THE RELEASEES;

6. I HAVE READ AND UNDERSTOOD THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
